		8	Original + 2 copies	 Proof of sufficient financial means Self-supporting: submit one of the following: bank statements and proof of income of the last 3 months, if you remain to obtain this income steadily during your studies in Belgium, OR Scholarship certificate issued by the university in Belgium, OR Financial certificate from the university in Belgium confirming an amount has been transferred to the university's account in Belgium for your living expenses during your studies. This is possible by signing an agreement between the university and yourself. When this is sent by email, it should also be sent by the university to the visa office of the Consulate General. By Guarantor: with following required documents: A. Annex 32 (available only in Dutch, French, or English). Completed but the guarantor signs only at the Consulate (fees apply). The sponsor should have his/her signature legalized at the Belgian Consulate competent for his/her place of residence. The sponsor needs to prove that he/she has sufficient income for himself/herself, his/her family AND for the student to honor his/her pledge of support.
